

Round Circle Model Release Agreement

You have been provided with this RC Model Release Agreement (“**Agreement**”) because you have been asked to model for photos (the “**Photos**”) on behalf of Round Circle Photo, LLC, its agents, legal representatives, successors or assigns (“**RC**”). Please read and review the following:

In consideration of my engagement as a model, and for other good and valuable consideration, I hereby give to RC permission, without limitation, the unrestricted, fully transferable, right and permission to:

1. reproduce, print, publish, distribute, broadcast, and otherwise use the Photos on or in the RC website, social media pages, videos, and any and all media now known or developed in the future, as well as all types of advertising and promotion or for any other lawful purpose throughout the world (collectively referred to as the “**Publications**”) of RC.
2. crop, edit, modify, distort, transform or otherwise alter or create derivative works from the Photos.
3. license or assign the Photos to its third parties in RC’s discretion.
4. include the Photos in its (or its assignees’) copyright registrations.

I understand that my name may or may not be included in the Publications (at RC’s discretion) and I waive the right to examine or approve the completed product or printed matter that may be used in conjunction with the Photos, or to demand the removal of any Photo(s) from any Publications. I understand that RC has complete creative control regarding use and modification of the Photos and this Agreement does not obligate the RC to make any use of any of the rights granted herein.

I understand that if I receive proofs from RC, they are not for use of distribution but only for their intended purposes as review proofs.

I understand that I have a limited license to include final Photo(s) in my professional portfolio, or for other purposes as agreed in advance by RC, and that I may crop but not blur or distort any Photo(s).

I hereby release and discharge RC from any and all claims, demands, or causes of action arising out of their use of the Photos as agreed to in this Agreement, including without limitation any claims based on any distortion, alteration, or use in composite form whether intentional or otherwise, that may occur or be produced in the taking of the Photos or in any subsequent processing and publication, as well as any claims of invasion of privacy, libel, defamation, disparagement, false light, violation of the right of publicity, or the like. I agree not to contest the validity of any of RC’s rights, nor to request any compensation for any future of the Photos in any Publications.

This Agreement shall be governed by and interpreted in all respects in accordance with the substantive laws of the state of Ohio and I agree that any disputes directly or indirectly arising out of or relating to this Agreement shall be resolved exclusively in the courts located in Cuyahoga County, Ohio. If any provision of this Agreement is determined to be invalid, such determination shall in no way affect the validity or enforceability of any other provision herein. This Agreement may not be modified except by a writing signed by both parties. This Agreement does not in any way conflict with any existing commitment on my part. I also acknowledge that the Agreement shall be binding upon my heirs, executors, administrators, and assigns.

I understand that I may obtain advice from legal counsel of my choice, to interpret these provisions. I am of the age of 18 or older, have read and understood this Agreement. By signing below, I acknowledge that I have

freely and voluntarily entered into this Agreement, I irrevocably give my consent, and understand that this Agreement shall be binding on my heirs, representatives, and assigns.
